

## THE JUNIPER ENTERPRISE AGREEMENT

A simple agreement to buy, consume, and manage software and SaaS licenses

Managing software and SaaS licenses is an important function of enterprise IT. When an enterprise has a large number of disparate licenses, managing them can require substantial IT resources. In addition, differing terms and structures can add to this difficulty while licensing costs can be unpredictable.

Due to these factors, many organizations lack visibility into their software consumption, especially when their needs change and unexpected growth patterns emerge.

To address these challenges, Juniper offers Enterprise Agreement (EA) options that provide:

- Ease of buying, consuming, and managing software for organization-wide use
- More efficient operations and an ability to respond quickly to changes in capacity

- Better return on aggregated software purchases with a longterm commitment
- The industry's first Al-Native Networking Platform, purposebuilt to leverage AlOps

All subscriptions are available up front and can be deployed at any time during the term. Wherever you are on your Al for Networking journey, we meet you there.

### Benefits and features

The Juniper Enterprise Agreement includes many benefits compared to a standard purchase agreement (Figure 1), which we've mapped to key outcomes (Table 1).

Juniper currently has two EA offers available to all customers: Custom EA and Packaged EA.

# Juniper Custom Enterprise Agreement for all software subscriptions

Juniper offers a Custom Enterprise Agreement for any software subscription or SaaS across Juniper's entire portfolio, allowing for consolidated procurement for multiple projects/use cases across multiple sites or for other business offerings, such as managed services.



Figure 2: Sample Juniper Custom Enterprise Agreement

In the example shown here (Figure 2), a customer buys 100 licenses over a five-year period at a growth rate of 20 licenses per year.

If licenses are consumed as per the agreed schedule, no extra cost is charged during the term. If the customer needs more than 100 licenses, additional licenses can be added to the Enterprise Agreement during the term for an additional price at the prenegotiated discount level.

## Juniper Packaged Enterprise Agreement for Juniper Mist Wired and Wireless Assurance




Figure 3: Key Features of Juniper Packaged EA for Mist Wired and Wireless Assurance

Juniper also offers a simplified Packaged Enterprise Agreement (Figure 3) for Juniper Mist™ Wired and Wireless Assurance.

- Easy and fast to purchase:
  - Subscription discounts are pre-approved; renewal at standard discount
  - Faster close as deployment forecast is not needed
- All hardware must be purchased up front, support is co-termed, and shipment can be deferred
- All other features of a Juniper Custom Enterprise Agreement also apply to Packaged Enterprise Agreement
